**Subject:- Regarding allocation of Schools pertaining to Agriculture skill.**

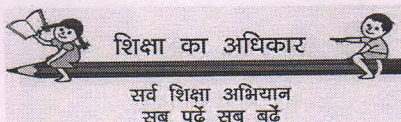

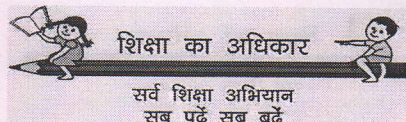
