The Scheme of Vocationalization of Secondary and Higher Secondary Education-list of job roles under the revised Pattern.

As you are aware, Department / HSSPP has been implementing CSS-VSHSE in 1065 Govt. Sr. Sec. School with 14 Skills (02 skills or 3 skills in each school). As per the guidelines received from MHRD, GOI for the implementation of vocational education, the schools can offer two vocational from Schools in each skill, one in 9^{th} & 10^{th} and other in 11^{th} & 12^{th} with 40 students in each section Thus, each course may be covered in a span of 2 years.

It is informed that the old Job Roles which are already under implementation will be phased out after the completion of the 04 years cycle. The new vocational courses as per new job roles have already been implemented from the academic year i.e. 2018-19 according to the revised model of implementation i.e. the course will be taken up in class 09th & 10th with exit at class 10th and another course preferably in the same line of progression will be taken up in class 11th, 12th with exit at class 12th

at class 12^{th} .

There are certain clarifications regarding implementation of vocational education as per the new job roles under the revised Pattern which are as under:


- In 1001 Govt. Sr. Sec. Schools covered between 2012-13 to 2017-18, the students enrolled in academic year 2017-18 now in class 11th & 12th will continue with the old Job Role as per Annexure-A till they passed out the class 12th with Level-4.
- The students enrolled in 1051 Govt. Sr. Sec. Schools in academic session 2018-19
 and thereafter will study vocational courses as per the new Job Role and details
 of job role is available at Annexure-B under the caption of Job Role-1.
- 3. It is also clarified that the students stands enrolled in 10th class in the academic session 2019-20 will study new curriculum as per the revised pattern and details of job role is available at Annexure-B under the caption Job Role-1. Also these students exit after completion of 10th class with competency in 01st job role (Span of 02 years).
